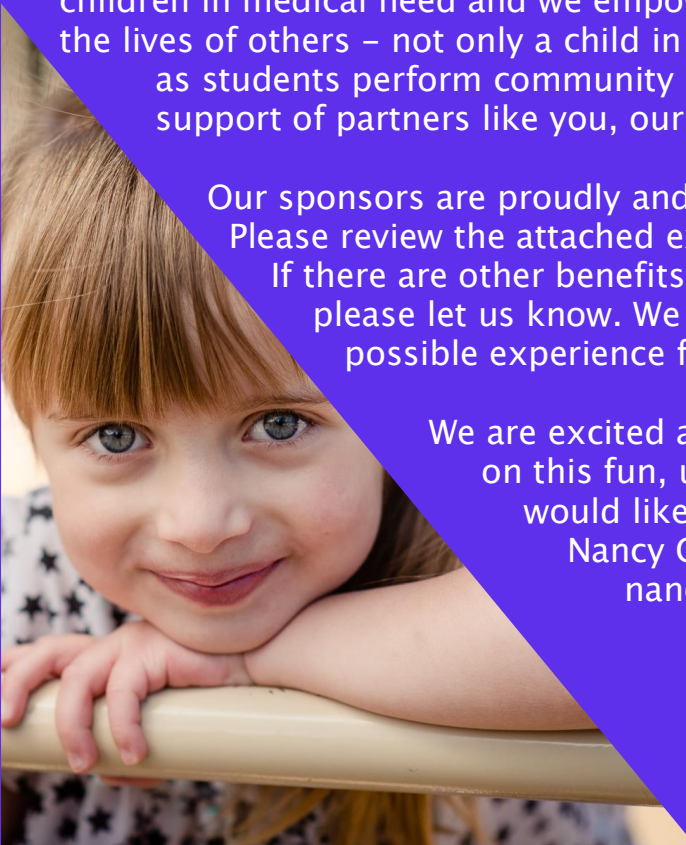
Your Participation
